Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act, 2003 to the effect that **SHAKTIBAS MAHATO, S/O- LT LAKKHAN MAHATO of VILL-SIMULTARD P.S.-PARA, Dist-Purulia**, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act, 2003 read with amendment of Electricity Act, 2007.

On 17.01.2019 at about 11:50AM, 1 GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C., along with LakshmanMahato, HG. Sr. LM, Dubra Para CCC, ManmathoMahali, Sr.TSH and BhakpadaMahato, TSH, Dubra Para CCC inspected the premises of **SHAKTIBAS MAHATO, S/O- LT LAKKHAN MAHATO of VILL-SIMULTARD, P.S.-Para, DistPurulia WBSSEDCL**. During inspection and it was found that the said **SHAKTIBAS MAHATO** was enjoying electricity unauthorizedly by direct hooking by service cable as hooking arrangement from WBSSEDCL's nearest low tension over head line for running his 02 nos CFL of 15watts, and 01 no ceiling fan of 65watts approx load 0.095 KW for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act, 2003 read with the amendment of Electricity Act, 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSSEDCL. The inspection team left the site at about 12:10PM.

As such **SHAKTIBAS MAHATO, S/O- LT LAKKHAN MAHATO of VILL-SIMULTARD, P.S.-Para, Dist- Purulia** has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act, 2003 read with amendment of Electricity Act, 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
