Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act, 2003 to the effect that **JABED ANSARY**, S/O- LT JAMAL ANSARY of VILL-PANARA, P.S.-Para, DistPurulia, the user of the electric. has committed an offence of theft of electricity under section 135 (1) (b) of Electricity Act, 2003 read with amendment of Electricity Act, 2007.

On 17.01.2019 at about 1:35PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Bilash Chandra Mahato, Hg.LM, Dubra Para CCC, LakkhanMahato,HG,Sr. LM, Dubra Para CCC, ManmathoMahali, Sr.TSH and BhaktipadaMahato,TSH, Dubra Para CCC inspected the premises of **JABED ANSARY**, S/O- LT JAMAL ANSARY of VILL-PANARA, P.S.-Para, DistPurulia WBSEDL. During inspection and it was found that the said **JABED ANSARY** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDL's nearest low tension over head line for running his 12nos15watts CFL, 06nos 75watts ceiling fan, 01no 190watts TV and 01no 180watts refrigerator ,approx load 0.970 KW for domestic purpose, which is an offence u/s. 135 (1)(b) of Electricity Act, 2003 read with the amendment of Electricity Act, 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDL. The inspection team left the site at about 1:50PM.

As such **JABED ANSARY**, S/O- LT JAMAL ANSARY of VILL-PANARA, P.S.-Para, DistPurulia has committed an offence of theft of electricity under section 135 (1)(b) of Electricity Act, 2003 read with amendment of Electricity Act, 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
