Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act, 2003 to the effect that *Sanat Rajwar, S/O-Late Madan Rajwar of Village-Hurra, P.S.-PARA, Dist-Purulia*, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act, 2003 read with amendment of Electricity Act, 2007.

On 29.01.2019 at about 05:45PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Avishkek Das, SAE(E) of Dubra Para CCC Manmatha Mahali, Sr. TSH of Dubra Para CCC and other staffs of Dubra Para CCC, WBSEDCL inspected the premises of *Sanat Rajwar, S/O-Late Madan Rajwar of Village-Hurra, P.S.-Para, Dist-Purulia* WBSEDCL. During inspection it was found that the said *Sanat Rajwar* was enjoying electricity unauthorizedly by direct hooking of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 06 nos. bulb 100 Watts and 01 no TV 60 Watt. approx load 0.660KW for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act, 2003 read with the amendment of Electricity Act, 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 6:00PM. As such *Sanat Rajwar* of *S/O-Late Madan Rajwar of Village-Hurra, P.S.- Para, Dist- Purulia* has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act, 2003 read with amendment of Electricity Act, 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
