I Sri Prashant Kishor, S/O - Kishori Prasad, A.E. & Station Manager of Telkalpara CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Dharani Kanta Das S/O Lt. Rathu Das of Vill - Lagda, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 30.01.2019 I, Prashant Kishor (AE&SM), along with Sri Debdan Bhattacharjee, Sr.SAE(E), Sri Chinmoy Maity, Sr.SAE(E) and Sri Debdulal Banerjee, Sr.TSH of Telkalpara CCC, WBSEDCL conducted a raid programme at village Lagda under Purulia(M) P.S. When our team at about 08.20 A.M. entered to the Domestic premises of Dharani Kanta Das, we found that he was enjoying electricity dishonestly by means of Direct Hooking from nearest LT/OH Line and run domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire and Immersion Heater dismantled and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 08.50 A.M. after completions of inspection & necessary formalities.

Dharani Kanta Das S/O Lt. Rathu Das of Vill - Lagda, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) of the Electricity (Amendment) Act-2007.
