In producing herewith the arrested accused persons namely (i) Ajit Kumar Mishra @ Lalu (24 yrs) S/O Late Bharat Mishra of Vill+PO- Tantri, PS- Joridih, Dist-Bokaro, Jkd & (ii) Dhananjoy Mandal (24 yrs) s/o Ashok Mandal of Vill- Dhawatard, PO-Tantri, PS- Joridih, Dist- Bokaro, Jkd and one seized vehicle (Pick-up van) having crushed wind glass with displaying tempered registration number having Engine No GA61H32508 and Chassis No 10020A0790N loaded with approx 05 quintal lump of iron scrap.

The nub of the fact in a nutshell is that today (18.01.19) I ASI Pradip Suparkar along with C/726 Dipankar Mahato C/254 karunamoy Bauri C/ 416 Sahadeb Hansda was performing PS mobile duty vide CC No 168/19 and GDE No 1050 Dated 18.01.19. During my PS mobile duty along Purulia-Ranchi Road received credible source information at about 12:55 hrs that a pick-up van of which the wind glass was crushed loaded with lump of iron scrap was coming from Chas More side towards Purulia Town. Subsequently I along with force reached at Imundi More and intercepted the Pick-up van at about 13:05 hrs and found on searching that the Pick-up van as well as its goods was identical as I received the prior information. On being asked, the driver of the said vehicle and his concomitant disclosed their names as noted supra. I asked the driver Ajit Kumar Mishra @ Lalu to produce the valid document in respect of the vehicle as well as the goods loaded on the vehicle. But the driver of the vehicle as noted supra could not produce any document in respect of the vehicle and the goods loaded on the vehicle. I asked repeatedly but they stated differently in different times. The incoherent statement of the driver and his concomitant purported to be a suspicious one to us. After the prolong interrogation they confessed before us that the vehicle, loaded with lump of Iron Scrap was stolen from Jharkhand side and proceeded towards Purulia for its disposal. The driver, Apt Kumar Mishra @ Lalu and his concomitant, Dhananjoy Mandal confessed their guilt, and they were directly involved in dealing with stolen property. The driver and his concomitant also stated that they had been running clandestine business of stolen property since long by dealing with this lump of iron scrap for a wrongful gain. As such there was every reason to believe that the driver, Ajit Kumar Mishra @ Lalu and his concomitant were habitually dealing the stolen property. So they are liable for offence punishable U/S 379/411/413/414 of the IPC. Subsequently, I seized the vehicle (Pick up Van) having crushed wind glass with displaying tempered registration number having Engine No GA61H32508 and Chassis No 10020A0790N loaded with approx 05 quintal lump of iron scrap preparing proper seizure list in presence of my accompanied staff and also arrested the accused driver ((i) Ajit Kumar Mishra @ Lalu (24 yrs) S/O Late Bharat Mishra of Vill+PO- Tantri, PS- Joridih, Dist- Bokaro, Jkd & (ii) Dhananjoy Mandal (24 yrs) s/o Ashok Mandal of Vill- Dhawatard, PO- Tantri, PS- Joridih, Dist- Bokaro, Jkd informing the ground of arrest and issued Memo of arrest and Inspection Memo against the both

Therefore I pray before you that a specific case against accused persons namely (i) Ajit Kumar Mishra @ Lalu (24 yrs) S/O Late Bharat Mishra of Vill+PO- Tantri, PS- Joridih, Dist-Bokaro, Jkd & (ii) Dhananjoy Mandal (24 yrs) s/o Ashok Mandal of Vill-Dhawatard, PO- Tantri, PS- Joridih, Dist- Bokaro, Jkd may kindly be started and arrange for its
