



Sir,

In producing herewith one Aswini Kumar (27 yrs) s/o Bholanath Kumar of Vill. Beidih, PS- Kankhila, Dist- Purulia, along with seized articles - (1) one improvised single shooter country made pipe gun (firearm) along with one round of .303 ammunition. I & Bangshi Badan Mondal of Purulia (T) PS do hereby lodge complaint that, on 25.01.19 at 21:05 hrs while myself along with C/1234 Mantul Mondal, NVF/493 Kiran Pal of Purulia (T) PS with Govt. vehicle No. WNF/4479 were performing anti-crime mobile duty, found a person was moving suspiciously at Sarsan Kal Mandir, Near Barakar Road, Ward No. 21, PS- Purulia (T) PS, Dist- Purulia. Seeing the Police party he started to flee away. However, we the Police party could manage to apprehend him who on interrogation disclosed his name and address as noted above.

On search of the person of said Aswini Kumar, found one improvised country made firearm loaded with one round of .303 live ammunition kept concealed on the left side waist under his wearing full pant covered by wearing shirt in his exclusive possession. On demand he failed to produce any document/authority for possessing and carrying such firearm & ammunition.

Accordingly, I seized the same after preparing a proper seizure list duly signed by my accompanying Police Force as well as I got it signed by the arrested person also and also duly labeled. As the place is lonely, none was available to stand as witness of the fact.

As the accused person under such circumstances committed an offence U/S 25(i)(a)/27 Arms Act, so I arrested him after disclosing his ground of arrest after issuing arrest memo etc.

I, therefore, pray that, a case U/S 25(i)(a)/27 Arms Act may kindly be started against the above-named accused person and also for arranging its investigation.
