I do hereby lodge complaint empowered by enabling the electricity act-2003 subsequently electricity (Amendment) act- 2007 to the effect that Yodhishtir Mahata (Present User) was enjoying electricity unauthorisedly i.e. bypass of energy meter by cutting of incoming service connection cable and due to this reason he has committed theft of electricity U/S 135 of the electricity (Amendment) act- 2007 on 17/01/19 at 4:45 pm at Achintya Mahata, At & SM. Raghunathpur, C.C. WBSEDC.

Entered the premises of Yodhishtir Mahata (Present User) Vill. Charpathari P.S. Raghunathpur, Dist- Purulia, having Consumer No. 24208896, Meter No. 12848041 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S 135(1)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDC energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric fan - 02 nos
- 2) Electric bulb - 02 nos
- 3) Color TV - 01 nos
- 4) CFL - 01 nos

Out of which I seized the following

1. PVE 2VE incoming service cable along with bypass arrangement - 12 ft (approx)
2. Energy meter no - L 2848041 - 01 nos

Seizure list was prepared at the site and accused person refuse to sign/sign. The inspection team left the premises at 04:35 pm on 17/01/19. The accused person has committed an offence U/S 135(1)(b) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
