Had an inspection at domestic premises of Mr. Jadhav Bauri S/O - LT Prayag Bauri, Vill - Bagmanoni, P.S. Raghunathpur and found that he was employing electricity unauthorised i.e. meter by passing through damage or cut the service cable at top and connected to two pc single core wire. The service cable was the wire directly connected to the his wiring.

After disconnection the time I seized 1 Tapping Portion of Service Cable with 2 PC wire (tapping cable) after length 2 ft - 3 ft with hold - 01 nos. in front of Mr. Pradip Bauri son of Mr. Jadhav Bauri duly signature on Seizer list:-
