Sir,

In producing herewith one accused person namely Motilal Mandi (68 Yrs.) S/o Lt. Nunka Mandi of Vill.- Jagannathdih, PS Raghunathpur, Dist- Purulia under arrest and the following seized articles under seizure list enclosed herewith: -

- 1) 28 (Twenty Eight) sealed bottles (CS) containing 600 ml each and labeled with DILSE.
- 2) Cash Rs. 240/- (Two hundred forty rupees) as sale proceed.
- 3) One plastic bag.

I do hereby lodge this complaint regarding that today 29.01.19 at about 21:05 hrs during my evening and anti crime mobile duty received source information over telephone that the above noted accused person has been selling liquor illegally & clandestinely of his house at Jagannathdih village. On receiving the reliable source information I communicated with O/C Raghunathpur PS over telephone and as per his instruction I along with C/1474 Tushar Kanti Mondal, 2) C/638 Lal Chand Bag and 3) C/431 Surendra Kr Dubey rushed to the spot to work out the information. On arriving at the house of Jagannathdih village, I apprehended the above noted person after a strong attempt and three customers seeing the Police party managed to escape. On close interrogation the above noted apprehended person had disclosed his name & address as above mentioned. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure and labeled the seized articles duly signed by the accompanying party and above noted accused in the seizure list and the label. After this I arrested that accused person namely Motilal Mandi (68 Yrs.) S/o Lt. Nunka Mandi of Vill.- Jagannathdih, PS - Raghunathpur, Dist.- Purulia after preparing proper memo of arrest.

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the arrested accused person namely Motilal Mandi (68 Yrs.) S/o Lt. Nunka Mandi of Vill.- Jagannathdih, PS - Raghunathpur, Dist.- Purulia under proper section of law and arrange for investigation.
