Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that *Samir Hazra S/O-Haradhan Hazra* of Village- Gohira, P.S.- Santaldih, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 29.01.2019 at about 07:05PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Avishek Das, SAE(E) of Dubra Para CCC Manmatha Mahali, Sr. TSH of Dubra Para CCC and other staffs of Dubra Para CCC, WBSEDCL inspected the premises of *Samir Hazra S/O-Haradhan Hazra* of Village- Gohira, P.S.-Santalidih, Dist-Purulia WBSEDCL. During inspection it was found that the said *Sanat Rajwar* was enjoying electricity unauthorizedly by direct hooking of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 03 nos bulb 100 Watts approx load 0.300KW for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 07:15 PM.

As such *Samir Hazra S/O-Haradhan Hazra* of Village- Gohira, P.S.-Santalidih Dist- Purulia has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act.2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
