Sir,

In producing here with the arrested accused persons namely 1) Israk Ansary (42) S/o Janab Ali Ansary of Uparjari PS Arsha Dist Purulia 2) Mansur Ansary (31) S/O Jumeruddin Ansary of Mishirdih PS Arsha Dist Purulia with one seized arms & ammunition as per seizure list. I ASI Dolan Das of Arsha PS Dist Purulia do hereby lodge complaint against 1) Israk Ansary (42) S/o Janab Ali Ansary of Uparjari PS Arsha Dist Purulia 2) Mansur Ansary (31) S/O Jumeruddin Ansary of Mishirdih PS Arsha Dist Purulia to the effect that today (07.02.19) in between 22:25 hrs to 22:55 hrs in course of mobile duty acting on a "tip of" myself along with C/ 744 Susanta Chakraborty C/129 Haripada Rajwar & HG/1580 Bishnu Pada Mahato , left for Satra more near Hanuman Mandir and keeping the vehicle at a distance. I made contact with source and as shown by him we identify two suspicious persons noted above loitering aimlessly at and around in front of grocery shop and mobile tower at Mishirdih more. We got closer after briefing accompanying force and in an opportunity moment we gharroud them and managed to apprehended them. On being asked they disclosed their identity as noted above. On search them we found one improvised fire arms loaded with one round live cartridge on back side waist in side wearing full paint of accused Israk Ansary and one live cartridge from the left side full paint pocket of accused SK Mansur . On being asked they failed to produce any document in respect of carrying and possessing the said fire Arms and Ammunition. So I seized the said fire Arms (Improvised pipe gun length approx 13 " including barrel loaded with one round live cartridge and one round live cartridge) being prepared proper seizure list. On further interrogation they failed to give any satisfactory answer for being present there at night time with said fire arms and ammunition. As such there is sufficient reason to believe that the said accused persons came to that place with an ulterior motive. So I arrested them and on return at Arsha PS, I submit my written complaint before O/C Arsha PS with a request to start a case and take law full action accordingly.
