On 21.02.2019 at about 2:25p.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Subal Chandra Dey, DE(E), Purulia RM Office, WBSEDCL 2. Sri Sukhamoy Maji SAE (E) Bagmundi CCC 3. Ashutosh Sharma SAE (E) Purulia RM Office, WBSEDCL, entered the premises of Sri Ashutosh Kumar, S/O- Lt Brindaban Kumar of village & P.O- Ekra, PS- Bagmundi Dist- Purulia and found Sri Ashutosh Kumar, S/O- Lt Brindaban Kumar was enjoying electricity unauthorized drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means of direct hooking to his house premises and connected load found 0.45 kVA. As Sri Ashutosh Kumar, S/O- Lt Brindaban Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sukhamoy Maji SAE (E) Bagmundi CCC 2. Ashutosh Sharma SAE (E) Purulia RM Office 3. Gurpratap Singh H G TSH. The inspection team left the premises at 2:55 p.m.
