On 08.02.2019 at about 2:20 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Chanchal Mondal, DE(E), Purulia RM Office, WBSEDCL 2. Sajal Kumar Mahanty, OE, Bagmundi CCC, WBSEDCL, entered the premises of Sri Biswanath Mahato, S/O- Sri Premchand Mahato of villege Gobinddih, P.O- Kushaldih, PS- Bagmundi, Dist- Purulia and found Sri Biswanath Mahato was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.25 KVA. As Sri Biswanath Mahato S/O- Sri Premchand Mahato committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sajal Kumar Mahanty, OE, Bagmundi CCC, WBSEDCL. The inspection team left the premises at 2:30 p.m..
