I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Chhutu Lohar, S/O- Sri Mahiram Lohar of villege Gobinddih, P.O- Kushaldih, PS- Bagmundi Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 08.02.2019 at about 2:40 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Baghmundih CCC along with 1. Sri Chanchal Mondal, DE(E), Purulia RM Office, WBSEDCL 2. Sajal Kumar Mahanty, OE, Bagmundi CCC, WBSEDCL, entered the premises of Sri Chhutu Lohar, S/O- Sri Mahiram Lohar of villege Gobinddih, P.O- Kushaldih, PS- Bagmundi, Dist- Purulia and found Sri Chhutu Lohar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.06 KVA. As Sri Chhutu Lohar S/O- Sri Mahiram Lohar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sajal Kumar Mahanty, OE, Bagmundi CCC, WBSEDCL. The inspection team left the premises at 2:50 p.m..
