



The humble petition on behalf of the Complainant

Most Respectfully sheweth:-

1... That the Complainant is a residence of Village Khairadih, P.S. Balarampur, District Purulia.

and

- 2...That the complainant has landed/properties at Village Parasya, P.S. Balarampur, District Purulia and within the jurisdiction of this Ld. Court.
- 3...That Muchiram Mahato father of the complainant purchased the Schedule land from Sufal Singh Sardar and others vide registered deed no.6530 pf 1965 and since then Muchiram Mahato was in possession. The Schedule land has been recorded in favour of



Muchiram Mahato. The father of the complainant transplated Palas trees on the land in question.

4...That after the death of Muchiram Mahato the accused persons in Serial Nos.1 to 4 were disturbing the complainant and tried to possess the Schedule land.

Then the complainant and legal heirs filed a Civil, case against Serial Nos.1 to 4 vide Title Suit No.360/10 and Ld. Court was pleased to pass an order in favour of the Complainant on 23.12.14. and restrained the accused persons in Serial Nos.1 to 4.

5...That on 5.1.19.in the morning hours the above named accused persons entered into the Schedule land ad after violating the Court's dirder cut the Palash trees forcibly and took away the same torcibly.

6....That on being informed by the witnesses the complainant went to the place of occurance and requested the above-named persons not to cut the trees but they were adament and tried to commit grevious hurt. The accused persons had/have Tangi, axe etc.on their hands. The accused persons also attemted to commit murder. The witnesses saved the complainant. The accused persons also threatened

the complainant with dire consequences. After that the accused persons filled up the digs with the help of female members to disappear the evidence and committed theft for which the complainant has lost of Rs. 25,000/- (Rupees Twenty five thousand) approximate . The accused persons have transferred/despatched the logs/either to sale or has stored the said loggs are still in the house of the accused persons, relatives houses. Some logs are still in the house of the accused persons. The witnesses were present at the place of occurance.

7.. That the Complainant went to Balarampur P.S. to lodge the complaint but O.C. Balarampur P.S. did not enquire the matter.

The complainant has informed the matter to the S.P. Purulia.

8.. That the complainant is aged about 65 years and he has no capacity to continue the case / at his own cost.

Hence it is prayed that your Honour would be pleased to send the petition to officer in charge Balaram pur P.S.tp treat the same as a F.I.R.under section 156(3) Cr.P.C.
