The humble petition on behalf of the complainant above named

Most respectfully sheweth:-

1. That the land bearing R.S.plot no.443 area 7 dec, and R.S. plot no.439 area 9 decimals of mouza Boladih under p.s. Bandwan previously belonged to one Bedani Mahatani, the grand mother of the complainant, exclusively. During R.S.operation the aforesaid lands have been recorded in the name of said Bedani Mahatani exclusively.
2. That while the said Bedani Mahatani was in exclusive possession over the aforesaid land she planted somany trees like Sonajuri trees and Jam trees and others trees therein. The said Budani Mahatani died & leaving behind his only son namely Pelaram Mahato as his legal heirs and representatives. The complainant is the son of said Pelaram Mahato, so the complainant is the rightful owner and possessor of the aforesaid lands and the complainant has got every right, title, interest and possession over the aforessid land as well as the aforesaid trees. The aforesaid trees were big one.
3. That the accused persons have got no right, title, interest and possession over the aforesaid land as well the aforesaid trees which are/were standing therein.
4. That on the date of occurrence i.e. on 16.12.2018 at about 11 A.M. all the accused persons named above being armed with deadly weapons like Lathi, axe etc, forcibly and illegally entered in to the aforesaid land of the complainant and they started to cut and remove

three nos of big Sonajuri trees and one Mango tree from the aforesaid plots of the complt. They also took away the entire aforesaid trees from the land of the complainant. The accused persons kept the aforesaid stolen trees in their Khamar bari. The value of the aforesaid stolen trees is about 40000/- (Fourty thousand). The aforesaid trees are still lying in the khamar Bari of the accused persons.

Sawing the aforesaid illegal activities of the accused persons, the complainant protested against the accused persons but they threatened to the complainant in a dire consequences. The complainant and his witnesses saw the incident and the matter was also reported to witnesses.

5. That thereafter the complainant reported the matter to the O/C Bandwan p.s. but O/C Bandwan p.s. did not start any specific case against them. The complainant also reported the matter to the RWA S.P. Purulia on 20.12.2018 but RWWK police of Bandwan p.s. did not take any appropriate step against the accused persons till today. So the complainant has been compelled to file this complaint before your Honour's Court.

6. That the complainant is poor man and he has got no capacity to conduct the case at his personal capacity and there is question of search and seizure, so the police case is required for the ends of justice.

7. That the accused persons have committed an offence u/s 447/379/506/34 I.P.C. and they should be punished accordingly.
