Respected Sir,

In producing here with arrested accused person namely Bharat Hansda (age-33 yrs) S/O-Lt. Tarachand Hansda of vill-Makopali, P.O-Kunchia, P.S. Bandwan, Dist. Purulia along with seized Illicit Liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 15:15 hrs received a credible source information over mobile that one person namely Bharat Hansda S/O-Lt. Tarachand Hansda of vill-Makopali, P.O-Kunchia, P.S. Bandwan, Dist. Purulia making a selling illicit liquor in his house under Bandwan PS. Accordingly I, along with officer and force namely ASI-494 Jashusei Bhattacharya, ASI-285 Subrata Patra, LC/928 Tarashankar Kar, LC/555 Chandni Kumari all are of Bandwan PS, Dist-Purulia & C/944 Sujan Singh, C/24 Tarani Sing Sardar left for Makopali Village to work out the said source information vide Bandwan PS C.C. No. 494/19, Dtd 14/2/19. Then, at about 16:35 hrs I reached at Makopali Village and found the said person was selling Illicit Liquor at the court yard of his house under Bandwan PS. So, with the help of accompany force I searched thoroughly with proper decency and maintains all legal formalities and found that he is selling illicit liquor. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized Illicit liquor approx 08 (eight) liters in a white plastic container after preparing proper seizure list duly signed by the witnesses and labeled.

Under the above circumstances, I therefore pray before you that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Bharat Hansda (age-33 yrs) S/O-Lt. Tarachand Hansda of vill-Makopali, P.O-Kunchia, P.S. Bandwan, Dist. Purulia and arrange for its investigation.
