Ashutosh Nag of village + P.O. - Bundwan was enjoying electricity unlawfully by means of Meter Bypass bearing Meter No H415580, Reference Id C/4235335 Has committed theft of electricity U/S 135/1 of The Electricity Act 2007. and caused revenue loss of WBSECL On 18/02/19 I, Romesh Singh, SM, Bundwan CCC, WBSECL

Entered the premises of Ambika Chohan Nag S/o Lt. Ashutosh Nag reside Vill + P.O. - Bundwan and inspect his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by means of Meter Bypass and caused revenue loss of WBSECL.

From the above arrangement he/she was using the following electrical equipments:
