At About 06:40 P.M., entered into the premises of Bijay Das, S/O Shankar Das of Vill- Chirudih, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill.- Chirudih, P.S Barabazar, DIST- Purulia.

During inspection, it was found that Bijay Das, S/O Shankar Das of Vill- Chirudih, P.S- Barabazar, Dist.- Purulia, his family was enjoying electricity illegally hooking from nearest LT OH line with the help of two core PVC cable in his premises at Chirudih having connected load 0.071 KVA.

- 02. 2 core PVC cable (14 Mtr. App.) along with hooking device.
