Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Mangal Das, S/O Paresh Das of Vill- Chirudih, P.S- Barabazar, Dist- Purulia, was enjoying electricity illegally hooking from nearest LT OH line with the help of two core PVC cable and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 18.02.2019, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) SAHEB SUTRADHAR, S.A.E(E), BARABAZAR CCC, WBSEDCL
- (2) NADEEM ANJUM, O.E., BARABAZAR CCC, WBSEDCL

At About 07:30 P.M., entered into the premises of Mangal Das, S/O Paresh Das of Vill- Chirudih, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill- Chirudih, P.S Barabazar, DIST- Purulia.

During inspection, it was found that Mangal Das, S/O Paresh Das of Vill- Chirudih, P.S- Barabazar, Dist.- Purulia, was enjoying electricity illegally hooking from nearest LT OH line with the help of two core PVC cable in his premises at Chirudih having connected load 0.118 KVA.

From the above arrangement he was using the following arrangements:

01. 01 no electric Bulb (100 watts)
02. 2 core PVC cable (11 Mtr. App.) along with hooking device.

Out of which I seized the following articles:

01. 2 core PVC cable (11 Mtr. App.) along with hooking device.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 07:50 p.m.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act-2007.
