I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Shankar Mandi S/O- Swendra Mandi of Village- Rampur, P.O- Dangorai P.S.- Boro, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 04/02/2019 at about 5.10 PM, Sri Swarnup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,
