Respected Sir,

In producing herewith one arrested accused namely Jiabul Mondal (50) S/o Lt. Golap Mondal of Vill- Punisol (Namo Mondal Para), PS- Onda, Dist- Bankura, with Memo of Arrest, Inspection Memo, Seizure list and seized articles viz. 1) one improvised single barrel fire arms having length Barrel – 11.02 cm, Body- 08.05 cm, Batt- 07.05 cm 2) 01 (one) round lives .303” cartridge, and 3) One red colour Hero Achiever Motor Cycle bearing Regd. No- WB68M/1849, Engine No- KC10EFCGK02020, Chassis No- MBLKC10EPCGK02111 under proper seizure list. I, ASI Sanjoy Banerjee of Hura PS beg to inform you that today (14.02.19) at about 15.35 hrs myself along with force while performing Naka checking duty at Ladhurka Check Post on Purulia Bankura road (NH-60A) vide Hura PS GDE No- 518 Dtd- 14.02.19 & C.C. No- 477/19 Dtd- 14.02.19 on that time I received an information from my reliable source that one person coming from Hutmura side towards Hura by a Motor Cycle WB68M/1849 with one fire arms. I informed the matter to O/C Hura PS for onwards transmission. During NAKA checking duty I detained one Motor Cycle rider along with his Motor Cycle having Regd. No- WB68M/1849. During search I found one improvised single barrel fire arms loaded with live cartridge from his left side waist. On asked he failed to produce any valid documents in respect of the shade fire arms. On interrogation he disclose his name & address as noted above.

Accordingly I seized 1) one improvised single barrel fire arms having length Barrel – 11.02 cm, Body- 08.05 cm, Batt- 07.05 cm 2) 01 (one) round lives .303” cartridge, and 3) One red colour Hero Achiever Motor Cycle bearing Regd. No- WB68M/1849, Engine No- KC10EFCGK02020, Chassis No- MBLKC10EPCGK02111 from his exclusive possession in-between 16:05 hrs to 16.55 hrs under proper seizure list and being labeled properly. During seizure & label I searched for the local disinterested persons to put sign on the Seizure List as well as Label, but no public witness could be made available. After seizure I arrested him at 17.05 hrs after observing all the legal formalities regarding arrest as his offence comes under the purview of Indian Arms Act.

Hence, I pray that a specific case may kindly be started against him under proper section of law and arrange for its investigation.
