



The Complainant above-named beg to state as follows:

- 1... That the Complainant and the accused persons are resident of Village Shyampur within P.S.Hura.
- 2... That the Accused persons have got a vacant land near the house of the complainant intervened by Kuli Rasta.
- 3... That on the date of occurrence i.e. on 16.11.18. the <sup>of the Complainant</sup> Accused persons came near the house 10 A.M. and stated as to why the Complainant has thrown rubbish and night soil in their land. The complainant told them politely that he did not throw any rubbish or night soil in the land of the Accused. The Accused persons uttered slang and abusive languages and went away to their house.
- 4... That at about 1 P.M. on that date when the Complainant was going to pond for bathing through the Kuli Rasta the accused persons suddenly appeared with some hard substance in their hands and Accused persons began to assault the complainant <sup>with</sup> that hard substance. The said accused persons without any provocation attacked the Complainant.
- 5.. That the Accused persons assaulted the complainant on the below of his right eye and over his head for the purpose of finishing his life. Bijoy Mondal and Fatik Mandal observed the incident.

6...That due to assault the complainant fell down on the ground Blood was oozing out from the body of the complainant .The Accused persons also assaulted the complainant over his ear.



The complainant has not been cured up till now and he has became hard of hearing. With a view to finish the life of the complainant .The Accused persons committed such offence. The accused Ananda Mondal is a civic volunteer .The accused persons are still roaming in the village and criminally intimidating the complainant and his family members. 
