beg to report that on 03/02/2019 at 22:05 hrs received a credible secret information that one gambling with huge amount is cong on in the Room No. 101 (1st Floor) of "Amantran Lodge" at Jhalda Ward No. I, P.S. Jhalda, Dist. Purulia. Accordingly, I diarized the coatter which refers to Jhalda PS G.D.E No- 93 Dtd. - 03/02/2019 and after obtain kind permission from I/C Jhalda P.S. I S.I Rana Bhakat dong with (1) SI Basudeb Acharya,(2) ASI Pankaj Kr. Gupta, (3) ASI Sk. Habibul Hasan, (4) C/1376 Tapan Das, (5) NVF879 Tapan Mahato, (6) MVF0039 Lalit Kishor Mahato, (7) NVF843 Bibekananda Mahato vide C.C No- 316/19 in vehicle No- WB-56C/8741 to work out the alformation. Then at about 22:25 hrs we reached "Amantran Lodge", Jhalda Ward No. I and very slowly & cautiously approached towards the Room No. 101 (1st Floor), where the gambling was reportedly going on. After that, we could be able to see from the gap of the doors as it wasn't closed fully that the persons present in the room are continuing gaming with playing cards in exchange of money which caused wrongful loss to one and wrongful gain to another. Accordingly, we entered into the room disclosing our identity and requested them to search the raid party. They searched ourselves and found nothing except wearing apparels, Mobile Phones, Pens and necessary papers. After that, we asked them to disclose their identity and they disclosed their name & address as noted above. It was found that a huge amount of currency note of different denomination and "Playing Cards" were kept on a pink coloured printed hed sheet which was the common place of playing Gambling in exchange of money. On demand, all the above noted persons clearly confessed that they along with few others are playing gambling through "Playing Cards" in exchange of cash with a view to wrongful loss to one and wrongful gain to another with full knowledge hiring the room with high price from the owner & Manager of the said Lodge) was well known about their purpose. Not only that, the above mentioned Yudhistir

We searched for the public witnesses but none was available there. We searched their persons and found some personal belonging, cash etc. I searched & seized the following articles in between 22:45 hrs & 23:25 hrs under proper seizure list duly signed by the witnesses and supplying one copy to them. Seized articles are- (i) Board Money of RS- 73,750/- (Seventy Three Thousand Seven modes and Sifty Ruped and Sift

Thereafter, I arrested all the above noted accused persons with proper decency after preparing memo of arrest and issued one copy to each as they committed offence which is punishable u/s- 3 & 4 of W.B.G & P.C Act.
