Sir.

In producing here with the accused person namely Anjar Sekh (30) S/o SK Samad of Kantadih, PS-Jhalda, Dist-Purulia, State-West Bengal brought under arrest along with seized articles as per seizure list i.e. one improvised country made fire arm (Iron made) length in total 10 inches having Iron butt, body, barrel, trigger, firing pin etc and 01 (one) rounds live ammunition, I, ASI Anil Ch Gorain of Joypur PS do hereby lodged a written complaint against the above noted accused person to the effect that on 07/02/2019 at 20:05 hrs while myself along with C/120 Sandip Kumar, JC/677 Manoj Das (Joypur PS GDE No 378 dated 07/02/2019 & CC No.568/19) both of Purulia Police line camp at Joypur PS were engaged in Special Mobile duty at Ranibandh Rail Gate and received a secret source information that one person was moving at near Jaltanki more under Joypur PS in suspicious manner. After receiving such information I informed to my IC over telephone and after discussion with IC Joypur PS directed me to work out this information. As such myself along with force C/120 Sandip Kumar, JC/677 Manoj Das immediately left to work out this information. We reached near to Jaltanki more and keeping our Govt. Vehicle in a safe distance we slowly moved to the information place and found said person was standing under a tree nearby for any crime upon the ongoing vehicle on Purulia-Ranchi pitch road at any time and we able to apprehended him and on being suspicion I search the said person and found that one improvised country made one shooter Iron made pipe gun loaded with one round live cartridge was kept in his left side of the waist under is full pant. On demand of papers he failed to produce any papers / documents in support of carrying / possessing such fire arms. On interrogation he disclosed his identity as noted above and made incoherent statement in respect of his presence at lonely place and also the purpose of possessing said fire arms and ammunition. It is reasonable to believe he choose the said along place pre-plainly to commit any grievous offence against vehicle etc. So finding no any other alternative way and after observing all the formalities I seized the said fire arms and ammunition under a proper seizure list in presence of witnesses as well as accused person and make over one copy of the seizure list to him and he put his signature as token of acknowledgement and also labeled the same by me. I tried my label best to singed the public witnesses as the place is a lonely place and far distance from villages so none were present there, So I unable to put signature any public witnesses on the seizure list. Hence I arrested him issuing memo of arrest as he is liable for prosecution u/s 25 (1) (a) Arms Act.
