Sir,

In producing here with the accused person namely Maruti @ Dilip @ Katla Kumar (23) S/o-Dhananjoy @ Buchu Kumar of Dakshin-Tatuara, PS-Kotshila, Dist-Purulia brought under arrest along with one seized motorcycle having Registration No- JH09Z-5988 & Engine No-HA10ELEHC23958 as per seizure list.

I, ASI Jagannath Rakshit of Joypur PS do hereby lodged a written complaint against the above noted accused person to the effect that on 12/02/2019 at 21:05 hrs while myself along with C/05 Biswajit Mahapatra, C/-245 Rabin Rajak, C/-589 Srinibas Mahato (Joypur PS GDE No 671 dated 12/02/19 & CC No.642/19) & CV/-79 Bivash Mahato & CV/-27 Aswini Mahato all of Joypur PS, Dist-Purulia were engaged in Naka checking duty at Kathatard strategic point at Jharkhand Border on Purulia -Bokaro Pitch Road (NH-32) and found the above noted person was coming from Pindrajora Side via NH32 towards Kathaltard by riding one motor cycle and on seeing the Naka Checking Party he tried to flee away by accelerating the speed, but failed to flee away. Immediately the Naka Checking team apprehended him at Kathaltard Naka Checking Point. I asked him why he tried to flee away. Then he made incoherent statement. I searched him on the spot including his motor cycle thoroughly and found nothing to note. On demand of papers in respect of said motorcycle he failed to produce Driving License and any papers / documents in support of carrying / possessing same. On carefully observation in respect of Engine Number & Chassis Number it could found that the Chassis No of the motor cycle is not visible and found the mark of rubbing on it and as such I failed to collect the Chassis Number. On interrogation he disclosed his identity as noted above and made incoherent statement in respect of his presence at that place and also the purpose of possessing the said motor cycle. So, it is reasonable to believe that he was stolen the above noted motorcycle from anywhere and possessing the same. So finding no any other alternative way and after observing all the formalities I seized the said motorcycle under proper seizure list in presence of witnesses as well as accused person and make over one copy of the seizure list to him and he put his signature as token of acknowledgement and also labeled the same by me. I tried my label best to sign the public witnesses but none is willing to put their signature on the seizure list. So I unable to put signature any public witnesses on the seizure list. Hence I arrested him issuing memo of arrest as he has violated the provision of Indian Panel Code.

During interrogation he confessed that he has stolen this motorcycle from Kotshila PS area under District Purulia and changed the Registration Number Plate and tried to erase the Chassis number as it easily visible from outside.

I therefore pray that a specific case may kindly be started against the accused person namely Maruti @ Dilip @ Katla Kumar (23) S/o-Dhananjoy @ Buchu Kumar of Dakshin-Tatuara, PS-Kotshila, Dist-Purulia, under proper section of law and arrange its regular investigation.
