As Anil Bauri, S/O-Ilt.Sokha Bauri committed theft of electric power.So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato ,Gr1 TSH ,Joypur CCC 02.Shibaram Mahato,HG TSH,Joypur CCC,03.Sristidhar Mahato,HG.TSH,Joypur CCC. The inspection team left the premises at 7.55 P.M.
