On 20.02.2019 at about 06.10 P.M . I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato ,Gr1 TSH ,Joypur CCC 02.Shibaram Mahato,HG TSH,Joypur CCC, entered the premises of Panbabu Ansary, S/O-lt.Abbas Ansary of village-Karkara P.S- Joypur , Dist- Purulia(Con Id-242170953,Meter No-OB4600520) and found Panbabu Ansary, S/O-Lt.Abbas Ansary(Con Id-242170953,Meter No-OB4600520) was enjoying electricity unauthorizedly drawing power from the incoming Service line of WBSEDCL through Al cable black colour by means meter bypassing to his furniture shop(Commercial) premises and connected load found 0.78 KW.
