

Sir,

In producing herewith one arrested accused person namely Hemanta Mahato (28) S/o- Haripada Mahato of Vill-Amtard, PS-Kotshila, Dist-Purulia A/P at Parga More, PS-Joypur, Dist-Purulia, State-WB under arrest along with seized articles as per seizer list i.e. approx 19 Liters (Nineteen) Illicit Distilled Liquor in 01 (one) white colour Plastic Jerrican under proper seizure with label.

I SI Atanu Chakarborty of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that today (21/02/2019) at about 18:25 hrs when myself along with C/237 Gopinath Roy, C/1226 Johnson Toon performed Naka Checking duty at Bartard more vide CC No-763/19 dt-21/02/19 and found that one person got down from on route bus with one white colour Plastic Jerrican. On suspicious ground I detained him on checking it is found that approx 19 Liters (Nineteen) of Illicit Distilled Liquor was loaded in this Jerrican. On demand he failed to produced any valid documents in respect of carring of such ID Liquor. On interrogation he disclosed his name and address as noted above. He also stated that he have collected the said ID liquor from Jharkhand side for selling the same to the local people illegally at Parga More in his shop under Joypur PS. So today in between 18:35 hrs to 18:55 hrs. I seized the same under proper seizure list & label duly signed by him and other available witness after taking 01 litters of ID liquor as sample out of 19 litters of ID liquor. During further interrogation he confessed his guilt as such I arrested him today 21/02/19 at 19:05 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Hemanta Mahato (28) S/o- Haripada Mahato of Vill-Amtard, PS-Kotshila, Dist-Purulia A/P at Parga More, PS-Joypur, Dist-Purulia, State-WB u/s-46A (c) of the Bengal Excise Act 1909.
