Banu Kalindi of village-Silphore, P.S- Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 30.01.2019 at about 5.45 P.M. I Sri Nilanjana Kumar Mondal, AE & Station Manager, Joypur CCC along with 01. Ganesh Mahato, Gr1 TSH Joypur CCC 02. Haragobinda Singh Mura, (OE), Joypur CCC, entered the premises of Anil Kalindi, S/O-Lt. Banu Kalindi of village-Silphore P.S- Joypur, Dist- Purulia and found Anil Kalindi, S/O-Lt. Banu Kalindi was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through CU cable red colour by means direct hooking to his house premises and connected load found 0.06 KW. As Anil Kalindi, S/O-Lt. Banu Kalindi committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01. Ganesh Mahato, Gr1 TSH Joypur CCC 02. Haragobinda Singh Mura, (OE), Joypur CCC. The inspection team left the premises at 6.05 P.M.
