During the inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest LTOH line of WBSEDCL i.e. U/S 135(1/a) was detected. From the above arrangement he/she uses the following electrical equipments.

Out of which I seized the following.

1. PVC two core cable fitted with hooking device approx length 12 feet's.
