I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sukumar Bawri S/O- Dwijapada Bawri of Village- Anandapur, P.O- Pedda P.S.- Mambazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 07/02/2019 at about 6:00 pm I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Sukumar Bawri, S/O- Dwijapada Bawri of Village- Anandapur, P.O- Pedda, P.S.- Mambazar, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthorisely by direct hooking from WBSEDCL LT line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -
