

Sir.

In producing here with one accused person Akteswar Nag(45) S/O Narayan Ch. Nag of village- Indkuri PS- Manbazar, Dist- Purulia along with following seized articles viz-

- (1) 42 (Forty two) bottles (in sealed condition) "DIL KHUSH" country spirit. 375 ml. each bottle = 15 ltrs. 750 ml and Rs- 42x22 = value Rs - 924/- (Nine hundred and twenty four) only
- (2) 05 pieces plastic glass
- (3) Sale proceed of Rs- 125/-
- (4) 05 pes. Empty bottle (DIL KHUSH) 375 ml. each

I S.I. Mahadeb Rana of Manbazar PS do here by lodged a complaint against accused namely Akteswar Nag(45) S/O Narayan Ch. Nag of village- Indkuri PS- Manbazar, Dist- Purulia to the effect that today (21.02.19) at 6:05 hrs. I received a telephonic information from a reliable sourcee that one Akteswar Nag(45) S/O Narayan Ch. Nag of village- Indkuri PS- Manbazar, Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I noted this information in GD vide Manbazar PS GDE No- 46 & C.C. No- 532 dtd- 21.02.19. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/56 Bidesh Chakraborty. C/1183 Subhas Kundu rushed to the spot for raid by Govt. vehicle. At about 16:25 hrs. my self along with force reached at Indkuri village and held rail in the road side shop of Akteswar Nag and found that said shop keeper selling liquor at his own shop and Seeing the police party some persons fled away and said Akteswar Nag tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Akteswar Nag(45) S/O Narayan Ch. Nag of village- Indkuri PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
