

The complainant/petitioner above-named  
Most respectfully begs to submit as follows:-

1. That the complainant is a resident of Village-Metyala, P.S.Mankazar, Dist.Purulia and within the jurisdiction of your Honour's court.
2. That on 12-12-2018 at about 5.00-5.30 P.M. in absence of the parents and relatives of the complainant, the above-named accuseds came to the house of the complainant and assaulted her indiscriminately by lathi and iron rod, the resulting of which the complainant got bleeding head injury.
3. That it is pertinent to say that after returning the parents and relatives of the complainant she narrated the entire incident to them and thereafter all of them went to Mankazar P.S. and ~~for~~ informed the incident to the O.C. of Mankazar P.S. and he advised the complainant and her relatives to take treatment of her bleeding head injury and the O.C. also expressed his inability to take any action against aforesaid accused persons because of pressure of political party.
4. That having no other alternative the petitioner lodged a written complaint to S.P.Purulia on 13-12-2018 for taking immediate action against the aforesaid ~~xx~~ accused persons.

Hence it is prayed that your Honour may kindly be pleased to admit this criminal Misc. petition and send it to the O.C. Mankazar P.S. for starting a specific case against the aforesaid accused persons after treating this petition as an F.I.R.U/S 156 (3) of Cr.P.C.
