that on today (04-02-2019) round about 16:05 hrs myself alongwith

- at Saltore Customer Care Centre had been in the house of Sri Amiya  
Mukherjee for inspection. For inspection a notice was served  
on Amiya Mukherjee which was duly received by Sri Asit Baner  
Mukherjee claimed as brother of Amiya Mukherjee.

A through inspection was conducted by me assisted by the  
Divisional Manager. During physical inspection it was found Sri  
Amiya Mukherjee enjoying electricity dishonestly by passing the  
energy meter at incoming terminal of meter SL no - L3899681  
against Commer id - 200391172 without registering the actual  
consumption on the meter. From the arrangement he was enjoying  
electricity to run the electrical equipments viz: ① CFL Lamp - 05 nos  
(18 watt each) ② Stand fan (01 nos, 160w) ③ Ceiling Fan - 03 nos (80 watt  
each) ④ Electric fridger - 04 nos (240w each) ⑤ Water Motor - 01 no (376 watt)  
⑥ Colour TV - 01 no (110 watt). Total load found - 1.986 kw.

This is a clear theft of electricity and Sri Amiya Mukherjee is liable for prosecution under Section 135(1)(b) of the IE Act 2003 amended on 2007. A copy of impaction report handed over to representative of Sri Mukherjee. The tapping procedure was photographed and enclosed. The service has been disconnected from pole.

I seized the following articles as per Seizure list duly signed by representative of Sri Mukherjee and WBSEDCL representative. A copy of Seizure list was handed over to the representative of Sri Mukherjee.

Article Seized:-

- ① One Energy meter bearing S/NO - L3899681, Make - Landis Gyr, with tapping joint/portion and a piece of incoming and outgoing cable.

- ② One no CFL Lamp fitted with holder - 18 watt.
- ③ One no change over Switch, Make - JJ deluxe, 32 Amp, 240 volt.
- ④ One no Electric Board fitted with 04 nos two pin Socket and One no Indicators with two nos two pin top.

In this context it is also to be noted that Sri Amiya Mukherjee has ~~not~~ <sup>not</sup> violated the Electricity Act - 2003 and amended 2007.

Label of the articles seized was prepared in presence of WBSEDCL representatives.

I therefore request you to start a case against Sri Amiya Mukherjee s/o Lt Kalikrishna Mukherjee under Section 135(1)(b) of the IE Act 2003 and arrange for investigation.

I handed over to you the impaction report, seizure list label all in original along with seized articles as per seizure list for taking action.
