Sir,

With due respect & humble submission I, Abhijeet Prasad (34) S/O- Lt. Biswanath Prasad of Sukanta Pally, South Dhadka, PS- Asansol (N), Dist- Paschim Burdwan would like to inform you that on 12.02.19 at about 15:00 hrs my younger brother namely Ranjeet Prasad (34) S/O- Lt. Biswanath Prasad and his colleague namely Vikash Prasad Sharma (41) S/O- Lt. Lakhan Prasad of Ningha Colliery, PS- Jamuria, Dist- Paschim Burdwan were returning to his office at Asansol from Raghunathpur side through Purulia-Barakar pitch road by a motorcycle bearing No- WB 44A/6188. On way at Inanpur one tractor bearing registration No- WB 39B/2598 with sand loaded trolley which was coming from Asansol side & heading towards Raghunathpur, dashed my brother and his colleague. Resulted in both sustained grievous injuries on their persons, locals shifted them to nearest health center "Harmaddih CHC" where the attending MO declared dead to Ranjeet Prasad and Vikash Prasad Sharma expired during treatment. Moreover the accident took place due to rush & negligence driving on the part of the driver of the said offending vehicle as well as the motorcycle has been fully damaged.

Under the above circumstances I pray before your good self that a specific case may kindly be initiated against the driver of the offending vehicle bearing no WB 39B/2598.
