Biswanath Prasad of Sukanta Pally, South Dhadka, PS- Asansol (N), Dist- Paschim Burdwan would like to inform you that on 12.02.19 at about 15:00 hrs my younger brother namely Ranjeet Prasad (34) S/O-Lt. Biswanath Prasad and his colleague namely Vikash Prasad Sharma (41) S/O- Lt. Lakhan Prasad of Ningha Colliery, PS- Jamuria, Dist- Paschim Burdwan were returning to his office at Asansol from Raghunathpur side through Purulia-Barakar pitch road by a motorcycle bearing No- WB 44A/6188. On way at Inanpur one tractor bearing registration No- WB 39B/2598 with sand loaded trolley which was coming from Asansol side & heading towards Raghunathpur, dashed my brother and his colleague.
