observed that the said Commen was enjoying electricity un-  
authorisedly i.e. by passing the energy meter by cutting the  
incoming service cable and from the arrangement he  
was enjoying electricity for the following equipments 1) Electric  
Heater - 01 no @ ~~1100~~ (750W), 2) Freezer - 01 no (120 watt).

3) Electric fan - 02 nos (60w each) 4) Colour Tv - 01 no (80 watt).  
05) Electric Bulb - 02 nos (100w each). The total load found was - 1.274 Kw. This is a clear theft of electricity and SK Rashid is liable for prosecution u/s - 135(1)(b) of the IE Act 2003 ammended on 2007. A Copy of inspection report was handed over to representative of SK Rashid. The Connection has been disconnected from pole side.
