for the following equipment ① Electric fan - 03 no (60 watt each) ② Battery
Charger - 01 no (250 watt) ③ Electric Motor - 01 no (1492 watt) ④ Electric
Bulb - 01 no (100 watt) ⑤ CFL - 02 no (09 watt each). Total load found
- 2.04 kW. This is a clear theft of electricity and Nandan
Goswami is liable for prosecution u/s- 135(1)(a) of the IE
Act - 2003 duly amended on 2007.
