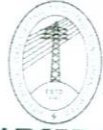

Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **MAILUDDIN ANSARI**, S/O- KURBAN ANSARI of VILL-BHALAGORA, P.S.-PARA, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 15.02.2019 at about 10:55AM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Mr. LakshmanMahato, HgSr LM, Dubra Para CCC, MrBhaktipadaMahato, Sr.TSH, Dubra Para CCC and other staffs of Dubra Para CCC inspected the premises of **MAILUDDIN ANSARI**, S/O- KURBAN ANSARI of VILL-BHALAGORA, P.S.-Para, DistPurulia WBSEDCL. During inspection and it was found that the said **MAILUDDIN ANSARI** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 02 nos bulb of 100watts, 01 no refrigerator of 180watts and 01 no LED of 09watts, approx load 0.389 KW for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 11:10AM

As such **MAILUDDIN ANSARI**, S/O- KURBAN ANSARI of VILL-BHALAGORA P.S.- Para, Dist- Purulia has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
