

It is to inform you that on date 1-2-19 at about 2.50 a.m. Night Duty staff deputed at OHE/Depot/ANR, Sri Mahadev Mahato, Helper/OHE/ANR rang me on mobile and informed me that Sir, come soon at OHE/Depot, as some unknown person entered in OHE/Depot and forcibly taken away OHE Material from OHE stores after damaging store locks. After getting information from my staff, I arrived at OHE/depot from Rly. Qtr. at ANR and observed that office stores locks in broken conditions and also OHE Material (mostly Copper items like, catenary wire rolls, Tail feeder wire rolls, dropper wires, OHE fittings, Copper scrap etc.) are missing from my stores. I also found walki-talkie missing from staff room, and some store material also in spreaded condition here and there. My staff also informed me that they (unknowns) have also taken away his Motor bike and Mobile phones with him along with OHE Materials.
