Dear Sir,

I, Aditya Ranjan, S/O - Late Rabindra Prasad,
of Mohr - Gaurav Nagar, P.O/P.S - Islampur, Nalanda, (Bihar)
would like to inform you that my brother-in-law
Mr. Ravi Ranjan Kumar, S/O - Kamdev Singh was
coming to Purulia from Rajhurnathpur side on
Purulia - Barabur Road by a Motorcycle bearing
no. WB 40X 3862. This was being driven by
Mr. Priyotosh Banerjee and Mr. Ravi Ranjan Kumar
was pillion rider. At around 7.05 P.M
one white coloured Scorpio bearing no. WB 39B-58⁵⁸
coming from the opposite direction with
excessive speed and negligent manner dashed
against the motorcycle from the
front side and then vehicle also hit one
auto car and another motorcycle. As a result
my brother-in-law and others got serious
injury and were shifted to Rajhurnathpur hospital
where my brother-in-law was declared dead.
I therefore request you to kindly ~~investigate~~
incedent the matter and ensure that strict punish-
ment is given to the driver of the Scorpio,

because of whose negligence my brother-in-law
