I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Chitta Bouri S/O- Satish Bouri of Village- Dhekia, P.O- Pairachali, P.S.- Puncha, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 14.02.2019 at about 06:28 PM, Sri Mrityunjay Mandal Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Sri Chitta Bouri, S/O- Satish Bouri of Village- Dhekia, P.O- Pairachali, P.S.- Puncha, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthorisely by direct hooking from WBSEDCL'S LT OH line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) One no. 100 watt bulb
- 2) one no. 20 watt CFL lamp

Out of which we seized the following -
