the energy meter i.e. U/S135(I) (a) was detected. The details of passing the arrangement was damage
installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his
house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- (i) Fan - 04 (four) no. each - 80 Watt
- (ii) c FL - 07 (Seven) each - 10 Watt
- (iii) Colour TV - 01 (one) - 100 Watt

Out of which I seized the following.

- (i) one no Single Phase meter no. B4092672
- (ii) Two Core pre cable 05 (five) Meters approx.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left
the premises at 12:30 P.M. on 19.02.2019. The accused person has committed an offence
U/S135(I) (a) of the electricity act-2003 subsequently electricity (Amendment) act.- 2007.
