And two PC single core cable connected to the service cable. This wire is directly connected to the wiring of meter in count the actual consumption. For this reason theft was detected under section 135(1)(b) of electricity act 2003 (Amendment act 2007).

After disconnection the wire I seized the damage service cable with meter by passing cable 3 ft approx. Seizer list prepared at side the accused person before to sign nature. submitted their complaint.


The infection team left the premises on 7/2/19 at about 5:10 pm.
