Sir,

In producing herewith an arrested accused person namely Dilkhush Ansary (40yrs), S/o -Lt. Asgar Ansary of Parbahal, PS - Santaldih, Dist. - Purulia with seized articles as an improvised country made fire arms loaded with one round .303 live ammunition in proper seizure list duly signed by the witnesses, I, SI Milon Manna of Santaldih PS do hereby lodge complaint that today (15.02.2019) at about 22:05 hrs when myself along with C/341 Wakil Mishra and C/749 Jaladhar Kaibartya both of Santaldih were engaged in night patrolling at Paharigora more and on that time received a secret information that a person is moving suspiciously on Raghunathpur Chandankiyari road near Harai river bridge under Santaldih PS. I inform the matter to I.C. Santaldih PS and duty officer. He diarized the matter in G.D.E. vide Santaldih PS G.D.E. no. 537, dated - 15.02.2019 and as per order of I.C. Santaldih PS, myself along with force left for Harai Bridge to work out-the information. Myself along with force reached on Raghunathpur Chandankiyari road near Harai river bridge at about 22:25hrs and found a person was moving suspiciously on that place and after seeing the police vehicle he tried to fled away. After a hot chase, we could able to intercept him. Being asked he disclosed his identity as above. But he gave in-coherent statements for his presence there. Then, I searched him and found an improvised country made fire arms loaded with one round .303 live ammunition from his exclusive possession. I asked him to produce valid license in respect of said fire arms but he failed to produce any valid documents in respect of possessing of said fire arms and ammunition. So, I seized said improvised country made fire arms loaded with one round .303 live ammunition in between 22:45 and 23:05 hrs after preparing proper seizure list duly signed by the witnesses. I also arrested the above noted accused person in 23:15hrs after maintaining all the formalities regarding arrest as he illegally possessed fire arms and live ammunition to use those for unlawful purpose. I also tried to collect the public witnesses but the place was lonely and nobody was available there to sign on the seizure list as public witness. After return to P.S, myself produce the arrested accused along with seized fire arms and live ammunition to start a specific case as per law.

Under above circumstances, I, therefore, pray that a case U/S 25(i)(a) of Arms Act may kindly be initiated against accused Dilkhush Ansary (40yrs), S/o -Lt. Asgar Ansary of Parbahal, PS - Santaldih, Dist. - Purulia.
