On 15.02.2019 at about 06.05 P.M . I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato ,Gr1 TSH ,Joypur CCC 02.Shibaram Mahato,HG TSH,Joypur CCC,03.Sristidhar Mahato,HG.TSH,Joypur CCC, entered the premises of Haradhan Kalindi, S/O-Lt.Chinibas Kalindi of village-Manakchita P.S- Joypur , Dist- Purulia and found Haradhan Kalindi, S/O-Lt.Chinibas Kalindi was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through CU cable Black colour by means direct hooking to his house premises and connected load found 0.2 KW. As Haradhan Kalindi, S/O-Lt.Chinibas Kalindi committed theft of electric power.So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato ,Gr1 TSH ,Joypur CCC 02.Shibaram Mahato,HG TSH,Joypur CCC,03.Sristidhar Mahato,HG.TSH,Joypur CCC. The inspection team left the premises at 6.20 P.M.
