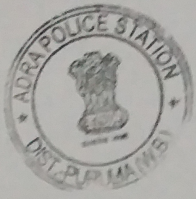


- 1) 18 bottles (in sealed condition) DIL SE 80 up country spirit, 600-ml each bottle and value-Rs-35 of each bottle.
- 2) 10 (Ten) pieces of plastic glass.

I ASI Parimal Tewary of Adra P.S. do here by lodged a complaint against accused namely Kartik Bouri (32 Yrs.) S/O Lt. Akul Bouri of Vill- Palashkola PS- Adra Dist- Purulia to the effect that on 11.03.19 at about 18:35 hrs in course of my evening mobile duty I received a telephonic information from a reliable source that one Kartik Bouri (32 Yrs.) S/O Lt. Akul Bouri of Vill- Palashkola PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with C/200 Dasharat Mahato & NVF/462 Dibakar Paramanik rushed to the spot for raid by Govt. vehicle. At about 18:55 hrs. myself along with force reached at Palashkola and hold raid in the house of Kartik Bouri found that said Kartik Bouri selling liquor at his own house and seeing the Police party some person fled away and said Kartik Bouri to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accused Kartik Bouri (32 Yrs.) S/O Lt. Akul Bouri of Vill- Palashkola PS- Adra Dist- Purulia and arrange for its investigation.
