S/O Sudhir Bouri of Vill- Ranguni PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with C/677 Sayad Julhar Ali & C/23 Chandi Das Mukherjee rushed to the spot for raid by Govt. vehicle. At about 17:25 hrs. myself along with force reached at Ranguni village and hold raid in the house of Ram Bouri found that said Ram Bouri selling liquor at his own house and seeing the Police party some person fled away and said Ram Bouri to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.
