Sub: Letter of complaint against Mr. Kanchan Tha (My Husband)

Respected Sir,

This is to state that I Rajeswari Mishra, Aged 31 years residing under your P.S Jurisdiction at Mission Para, Panchudanga near Milan Sporting Club, Adra, W.B. that Mr. Kanchan Tha aged 36 years, residing at Desbandhu Road, Sufalpally near Old power house, Purulia, West Bengal using mobile no. 7602707522 has made my and my whole family life hell.

Sir in reference to the above, this is further to bring at your kind notice that I Rajeswari Mishra & Mr. Kanchan Tha was married to each other on 08.12.2010, since after 4 months after my marriage Mr. Kanchan Tha regularly started drinking and after drinking, every night create nonsense and also started lifting hand / beating me, I Rajeswari Mishra at the begining stage complained about these issues to Kanchan Tha parents, but in return, they also started supporting their son Mr. Kanchan Tha and inspite of scolding / taking any action my Husband's parents started using cheap & slang language's and sometimes lifting hands on me. As well when I became pregnant my husband and his mother started torturing me, such as they would pressurise me to lift water from well, present at their house, they also use to pressure my me down in the pregnant condition & clean the floor of their house etc. because of that

Sir since last 3 months again suddenly after drinking M & Kanchan Tha has started disturbing & threatening me, without any reason, but parents personally suggested me to ignore my husband nonsense but on 23rd of January he tried to grab my neck and holded it tightly and tried to kill me. I somehow managed to hit him in his legs and escaped from there.

Sir on 16.03.2019 evening around 7:30. M & Kanchan Tha accompanied with 4 more unknown person and threatened my parents at my house at Adra, M & Kanchan Tha demanded that he will immediately take back my daughter from my house. Sir since I was not present on that day in Adra, I was at Kolkata. They ignored my husband M & Kanchan Tha because he was drunken. They told him to go back or my parents will call police. My husband M & Kanchan Tha started abusing my parents and my family. As well he gave my parents final warning "That make me understand or else he will ensure I see to that, I doesn't ^{return} back home alive from Kolkata." As well if my parents don't allow my daughter to go with him, he will also see it someday from her school, she won't return back home.

Sir being a citizen of Adra I do humbly request you to take necessary strong steps against M & Kanchan Tha I also do request you to kindly see to it

my baby was miscaraged.

Sir finally when I saw no solution are coming out 2 day by day things going on bad results. I then finally decided to bring those entire matters / issues / problems at my parents knowledge. After knowing these issues, they personally tried to make my husband Mr Kanchan Tha understand, but in return, he not only abused my parents but also warned them and started giving threats, that if they tried act smart, then he will throw me out of their house.

Then after my parents brought back me & my daughter Rajni Tha aged 6 years from their house to our house in Adea, in front of Mr Kanchan Tha & his parents, at that time nobody from their house and family did stopped to do so.

Then after, ^{now} did Mr Kanchan Tha nor his family members took any reports / news about my daughter Rajni Tha and me. In these 8 month (approx) Mr Kanchan Tha or his family members has not given a single rupee to me and my daughter Rajni jha expenses.

In the ^{mean} time for a change my parents allowed me to work in a private limited company in Kolkata & also stay there for work. At that time my husband Mr Kanchan Tha came to Kolkata on 23rd of January and threatened me and tried to kill me by grabbing my neck.
